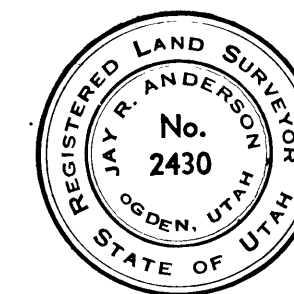
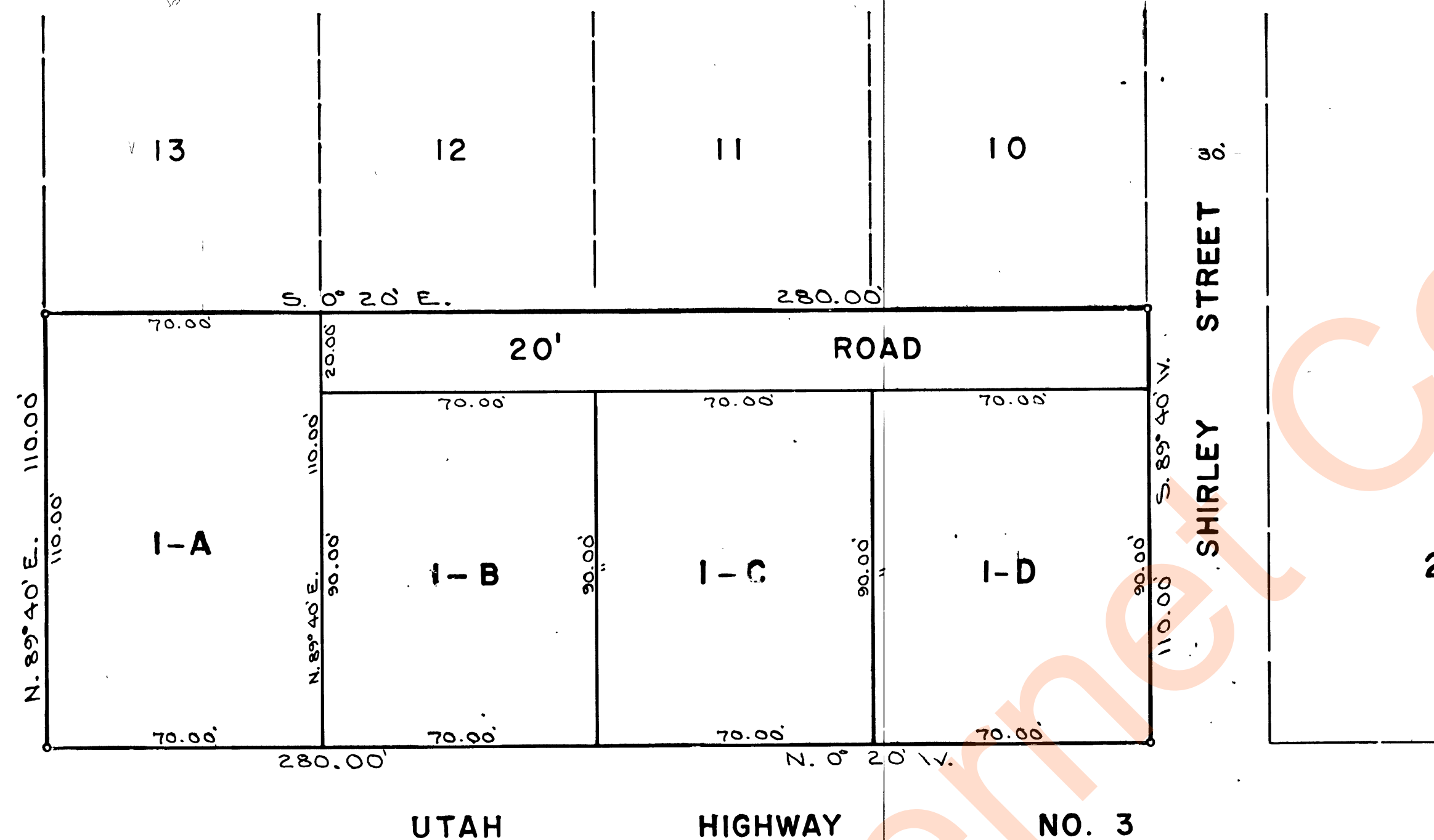


Amended Plat Lot No. 1
