

ENGINEER'S CERTIFICATE

PICKLEVILLE TOWN

I, Willis A. Tingey, a licensed Professional Engineer and Land Surveyor, do hereby certify that at the request of Stan Naisbitt have caused a survey to be made for the purpose of (1) Sub-Dividing a part of BLUE WATER BEACH and (2) locating the boundaries of said Beach here to agreed upon together with the preparation of the necessary Plat and description for record and filing purposes before the Pickleville Town Board, for approval, and at the Rich County Recorder's Office for registration and recording. Said Lands being located in SE 1/4 Section 33, T 14 N, R 5 E, Salt Lake Meridian. I certify that the boundary of BLOCK "A" BLUE WATER BEACH SUB-DIVISION were as follows:

TRACT No. 1. BLOCK "A" BLUE WATER BEACH SUB-DIVISION

Beginning at a Point North 1320.00 ft and N 89° 20' W 105.1 ft more or less from the NE Corner Section 33, T 14 N, R 5 E, Salt Lake Meridian; thence N 89° 20' W 424.37 ft more or less to the East Boundary of a 20 Foot Private Right of Way Bearing N 23° 40' E; thence S 20° 40' W 252.40 ft more or less along the East Boundary of said Private Right of Way to the North Boundary of a 66 foot Public Right of Way Bearing S 69° 20' E; thence N 69° 20' W 20.00 ft along said Public Right of Way to the West Boundary of said Private Right of Way Bearing N 20° 40' E; thence N 20° 40' E 244.9 ft more or less along the West Boundary of a Said Private Right of Way to a point N 89° 20' W 115.56 ft. more or less from the SE Corner Lot 5, Section 33, T 14 N, R 5 E, Salt Lake Meridian; thence N 20° 40' E 110.17 ft more or less; thence N 30° 05' E 20.14 ft more or less to the SW Corner Lot 5, Block "A" BLUE WATER BEACH SUB-DIVISION; thence N 23° 07' E 254.24 ft. more or less to the Meander Line of Bear Lake established by U. S. Land Surveys dated Oct. 10, 1875; thence S 63° 15' E 332.44 ft more or less along said Meander Line to the NE Corner Lot 5, Section 33, T 14 N, R 5 E, Salt Lake Meridian and in the East Boundary of a 15.1 foot Private Right of Way Bearing S 26° 45' W; thence S 26° 45' W 233.65 ft. more or less along the East Boundary of said Private Right of Way to the Point of Beginning. Further described as being located in SE 1/4 Section 33, T 14 N, R 5 E, Salt Lake Meridian containing 2.398 Ac more or less and marked as shown on the accompanying plat and map.

I further certify that the boundaries here in described conforms to the following conditions:

- (1) That all boundaries conform to the Tingey Survey on all sides except as follows:

a. Tract No. 2 Described as follows:

Beginning at the SE Corner Lot 5, North 1320.00 ft from the SE Corner Section 33, T 14 N, R 5 E Salt Lake Meridian; thence N 89° 20' W 105.1 ft. more or less along the South Boundary said Lot 5 to the East Boundary of a 15.1 ft. Private Right of Way Bearing N 26° 45' E; thence N 26° 45' E 233.65 ft more or less along the East Boundary of said Private Right of Way to the Meander Line Corner between Sections 33 and 34, T 14 N, R 5 E, Salt Lake Meridian on the Shore of Bear Lake and the NE Corner Lot 5, Section 33; thence South 209.68 ft more or less along the Boundary between said Sections to the Point of beginning. Further described as being located in Lot 5, Section 33 T 14 N, R 5 E, Salt Lake Meridian containing 0.230 Acres more or less and marked as shown on the accompanying plat.

b. West Section of BLOCK ONE IDEAL BEACH DOWNSITE
Ideal Beach Townsite as re-established by W.A. Tingey in accordance with original Court Records and Court Decrees.

c. Traverse Line established by agreement between adjacent Owner's. Said Traverse Line was described as follows:
Beginning at a Point N 1320.00 ft and N 89° 20' W 861.50 ft more or less from the SE Corner Section 33, T 14 N, R 5 E, Salt Lake Meridian (Point No. 8 Birch Survey) and in the South Boundary Lot 5 Said Section 33; thence N 89° 20' W 80.22 ft. more or less along the South Boundary said Lot 5 to the East Boundary Lot 44, of the Revised and Corrected REAL BEACH SUB-DIVISION; thence 31° 16' E 152.73 ft. more or less along the East Boundary Lots 44 and 45 and the projection of said boundaries; thence N 59° 26' W 447.94 ft. more or less to a point S 59° 26' E 11.0 ft. from a fence bearing S 24° 50' W; thence S 24° 50' W 352.20 ft. more or less offset 11.0 ft and parallel with said fence to a State Highway Right of Way.

d. The Boundary on the West Was established by Ownership.

Beginning at a Point N 1320.00 ft and N 89° 20' W 165.00 ft from the SE Corner Section 33, T 14 N, R 5 E Salt Lake Meridian; thence N 66° 53' W 57.9 ft. thence S 23° 17' W 26.4 ft. more or less to the South Boundary Line Said Lot 5 Section 33; thence S 89° 20' E 62.57 ft more or less along said Line to the Point of beginning. Further described as being located in Lot 5, Section 33, T 14 N, R 5 E Salt Lake Meridian containing 0.017 Acres more or less and marked as shown on accompanying plat.

Tract No. 4. Area In Right of Way No. 3, but actually part of Tract No. 2.
Beginning at the NE Cor. Lot 5, Section 33, T 14 N, R 5 E, Salt Lake Meridian (Meander Cor. Between Sections 33 and 34); thence S 26° 45' W 233.65 ft more or less to the South Line Said Lot 5; thence N 28° 11' E 233.65 ft more or less (in line with iron pipe) to the meander line of Bear Lake established by U.S. Land Surveys dated Oct. 10, 1875 bearing N 73° W; thence N 73° W 6.45 ft more or less along said meander line to the Point of Beginning. Further described as being located in Lot 5 section 33 and a bit in SW 1/4 Section 34, T 14 N, R 5 E Salt Lake Meridian containing 0.0217 Acres more or less.

I further certify that lots and private right of ways with their dimensions are shown on this map and that said boundaries hereon shown were staked out in the field as shown on the accompanying plat to a scale of 1" = 100 feet. And that it was drawn from field notes and information on file in my office.

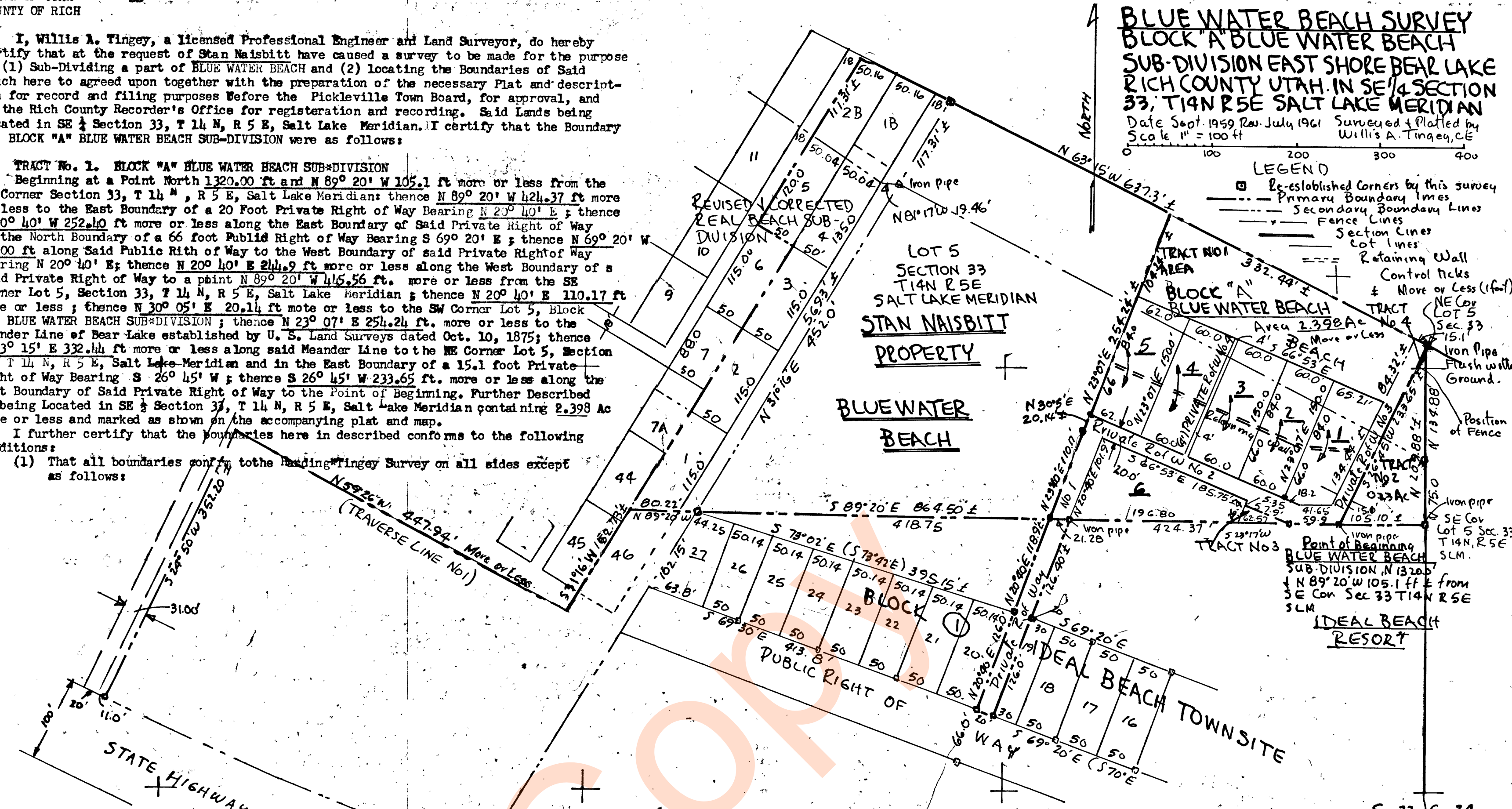
