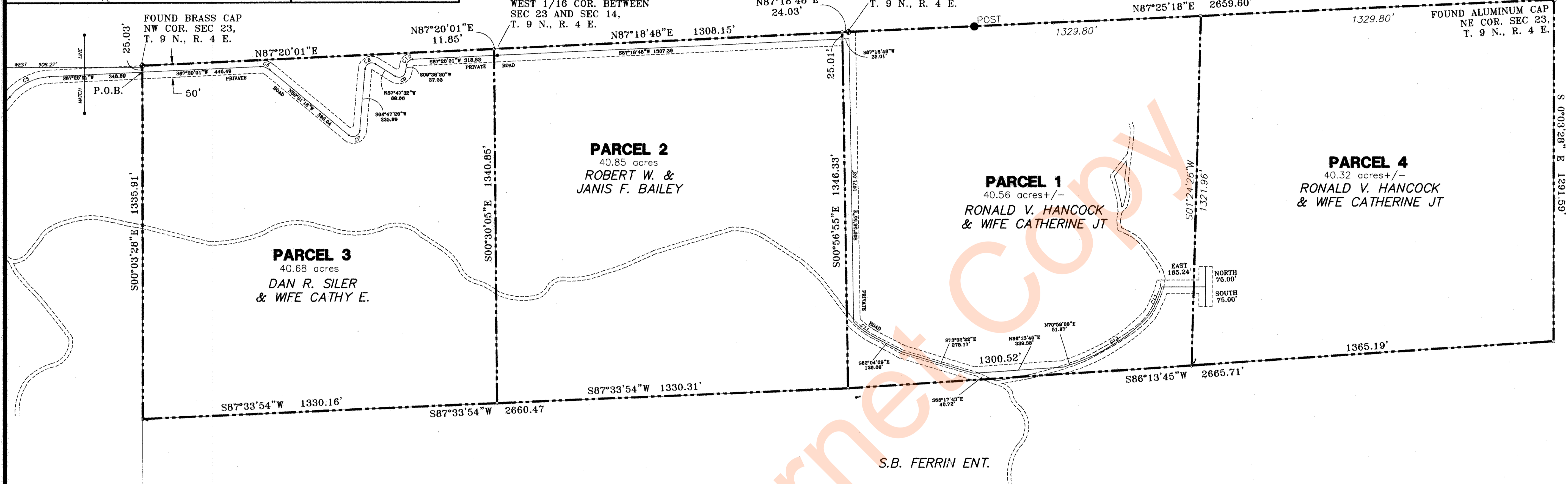
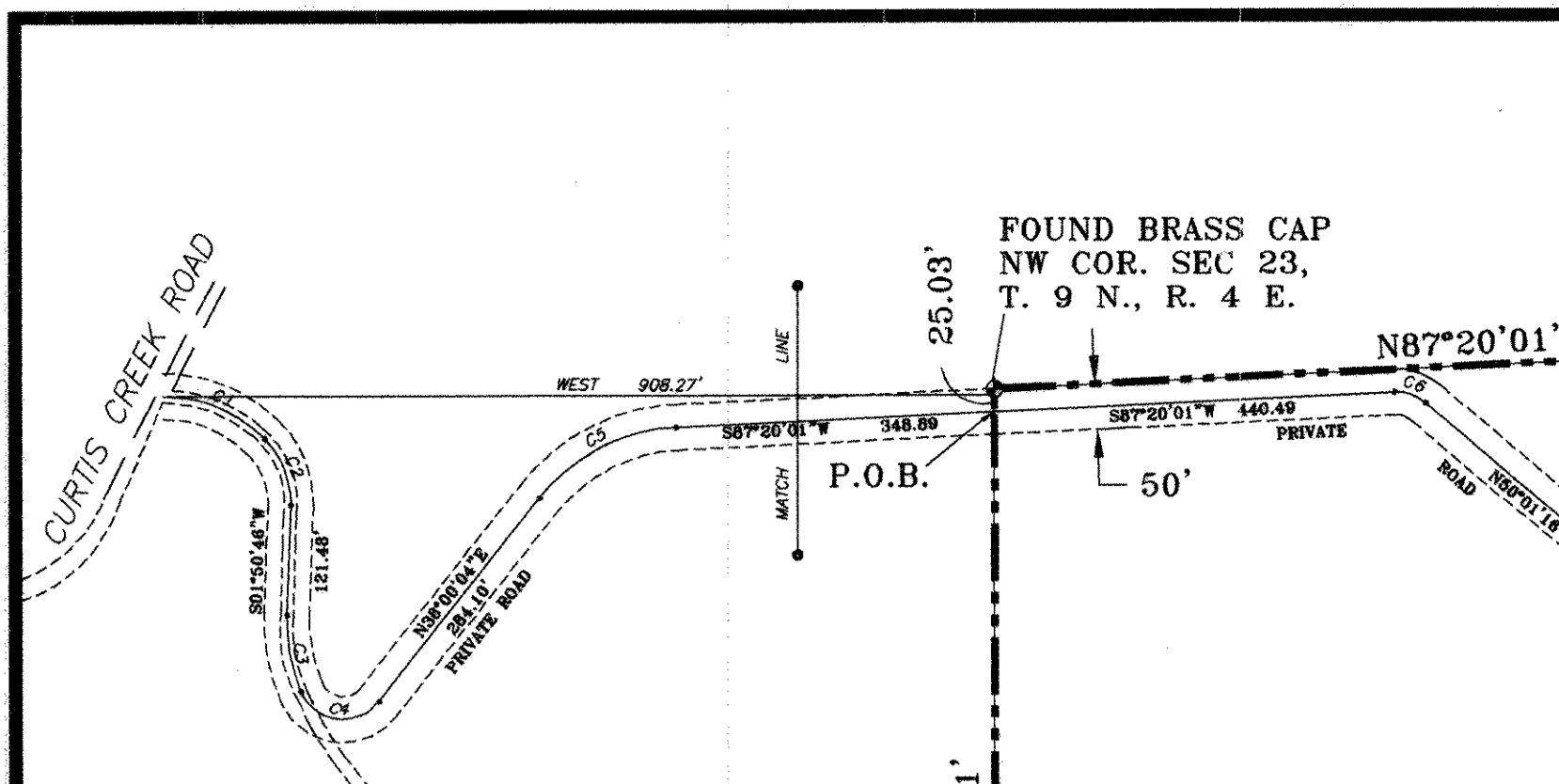
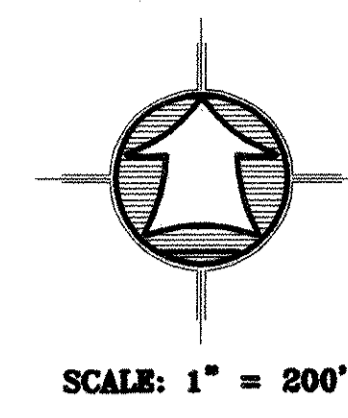

SURVEY NARRATIVE

- THE BASIS OF BEARING FOR THIS SURVEY IS NORTH 87°25'18" EAST ALONG THE NORTH LINE OF THE NORTHEAST QUARTER OF SECTION 23, TOWNSHIP 9 NORTH, RANGE 4 EAST OF THE SALT LAKE BASE AND MERIDIAN.
- THE PURPOSE OF THIS SURVEY IS TO SUBDIVIDE THE SHOWN AREA INTO FOUR PARCELS AS SHOWN.
- RETRACEMENT: NORTH LINE IS ALONG THE NORTH LINE OF THE SECTION BY FOUND SECTION MARKERS, EAST AND SOUTH LINES ARE NEW LINES, WEST LINE BY WEST LINE OF THE SECTION FROM FOUND MARKERS.
- SET 5/8" REBAR AND CAP AT PROPERTY CORNERS AS SHOWN.
