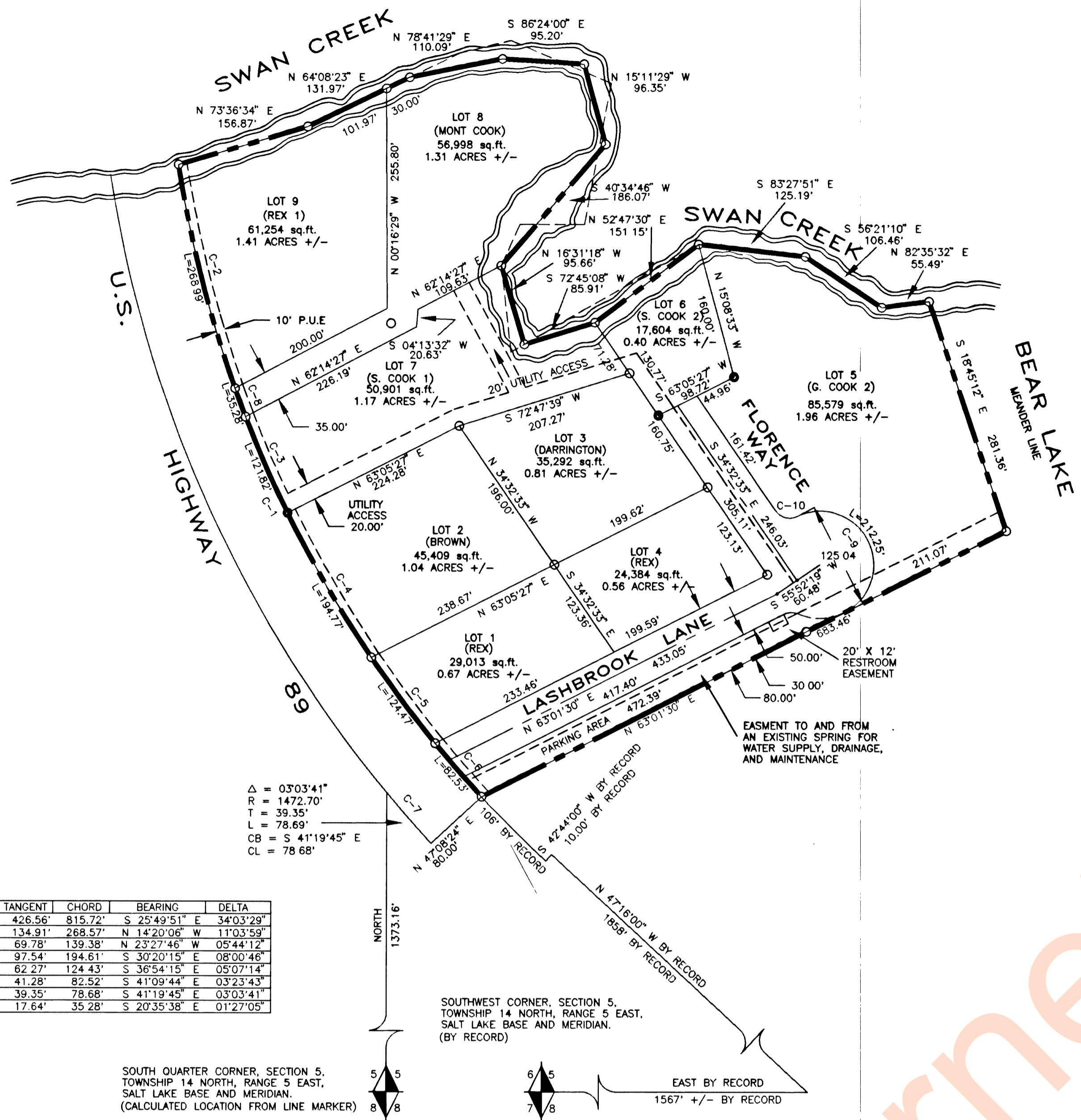

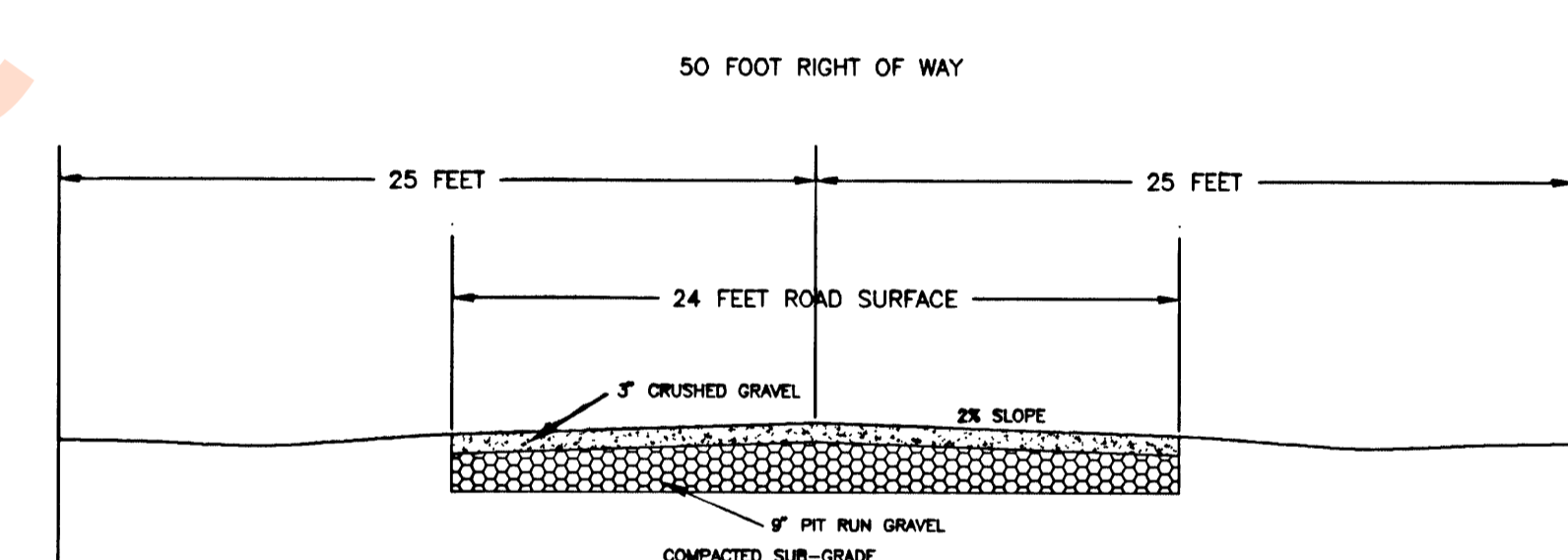

 - EAST RIGHT OF WAY LINE OF U.S. HIGHWAY 89 REESTABLISHED FROM RECORD AND LOCATION OF RIGHT OF WAY FENCE. NORTH PARCELS FROM RECORD AND SWAN CREEK LOCATION.

SURVEYOR'S CERTIFICATE

I, WAYNE CROW, DO HEREBY CERTIFY THAT I AM A REGISTERED LAND SURVEYOR, AND THAT I HOLD CERTIFICATE NO. 6162, AS PRESCRIBED UNDER THE LAWS OF THE STATE OF UTAH. I FURTHER CERTIFY THAT BY THE AUTHORITY OF THE OWNERS, I HAVE MADE A SURVEY OF THE TRACT OF LAND SHOWN ON THIS PLAT AND DESCRIBED BELOW, AND HAVE SUBDIVIDED SAID TRACT INTO LOTS AND STREETS, HEREINAFTER TO BE KNOWN AS: L.L. COOK, HATTIE Y. COOK SUBDIVISION (AMENDED) AND THE SAME HAS BEEN CORRECTLY SURVEYED AND ALL STREETS ARE THE DIMENSIONS SHOWN.

BOUNDARY DESCRIPTION

PART OF LOT 4, LOT 5, AND THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 5, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTH QUARTER CORNER OF SECTION 5, TOWNSHIP 14 NORTH, RANGE 5 EAST, SALT LAKE BASE AND MERIDIAN AND THENCE NORTH, 1373.16 FEET TO THE WEST RIGHT OF WAY LINE OF U.S. HIGHWAY 89; THENCE ALONG SAID WEST RIGHT OF WAY LINE 78.69 FEET ON A CURVE TO THE LEFT, WITH A RADIUS OF 1472.70 FEET, INCLUDED ANGLE OF 3°03'41" AND A LONG CHORD THAT BEARS SOUTH 41°19'45" EAST, 78.68 FEET; THENCE NORTH 47°08'24" EAST, 80.00 FEET TO THE EAST RIGHT OF WAY LINE OF SAID HIGHWAY AND A POINT OF RECORD THAT LIES EAST, 1567.00 +/- FEET, NORTH 47°16'00" WEST, 1858.00 FEET, SOUTH 42°44'00" WEST, 10.00 FEET, AND 106.00 FEET ALONG A CURVE ON THE EAST RIGHT OF WAY LINE OF U.S. HIGHWAY 89 FROM THE SOUTHWEST CORNER OF SAID SECTION 5 AND THE TRUE POINT OF BEGINNING;

AND THENCE NORTH 63°01'30" EAST ALONG AN EXISTING FENCE, 683.46 FEET TO THE MEANDER LINE OF BEAR LAKE; THENCE NORTH 18°45'12" WEST ALONG THE MEANDER LINE OF BEAR LAKE, 281.36 FEET TO THE CENTER LINE OF SWAN CREEK; THENCE WESTERLY ALONG THE CENTER OF SWAN CREEK IN THE FOLLOWING 12 COURSES:

THE UNDERSIGNED OWNERS HEREBY GRANT, CONVEY AND DEDICATE ALL EASEMENTS SHOWN AND DESIGNATED ON THIS PLAT FOR USE AS ROADWAYS (EXCEPTING ONLY THE STATE-OWNED RIGHT OF WAY FOR WHAT IS KNOWN AS U.S. HIGHWAY 89), PARKING, PATHS, RIGHTS OF WAY, OR OTHER MEANS OF ACCESS TO BEAR LAKE, TO THE ADJOINING FISH HATCHERY, OR TO THE LOTS OR ANY COMMON AREAS WHICH FORM PART OF THIS AMENDED AND SUBSTITUTED SUBDIVISION PLAT, FOR THE EXCLUSIVE AND PRIVATE USE OF ONLY (1) THE BENEFICIARIES OF THE WATERFRONT TRUST FORMED DECEMBER 29, 1958, BETWEEN HATTIE Y. COOK AND HATTIE Y. COOK AS ADMINISTRATRIX OF THE ESTATE OF LASHBROOK L. COOK, DECEASED, TRUSTORS, AND ALTON D. COOK, TRUSTEE, CONVEYING IN TRUST CERTAIN REAL PROPERTY IN RICH COUNTY, UTAH, ADJOINING BEAR LAKE TO SAID TRUSTEE FOR THE BENEFIT OF THE DESCENDANTS OF SAID LASHBROOK L. COOK, FOR THE USES SPECIFIED IN SAID TRUST; (2) THE PRESENT AND FUTURE OWNERS OF SUCH OF SAID LOTS SHOWN HEREON AS ARE OR MAY BE BENEFITTED THEREBY; FOR AS LONG AS SAID OWNERS OWN THESE LOTS, AND FOR THE LIMITED PRIVATE INCIDENTAL USE OF THEIR INVITED GUESTS; (3) ALSO TO THOSE CERTAIN DESCRIBED OWNERS OF NEARBY LAND PARCELS LOCATED (A) IN THE SWAN CREEK VILLAGE SUBDIVISION, AS REFLECTED IN THAT CERTAIN WARRANTY DEED RECORDED ON MAY 31, 1994, AS FILING NO. 45568, BOOK W6, PAGES 327-332, OF THE RECORDS OF THE RICH COUNTY RECORDER'S OFFICE, AND AS REFLECTED IN THE OTHER DOCUMENTS REFERRED TO THEREIN, AND LOCATED (B) IN OTHER PARTS OF WHAT WAS ONCE THE CODU RANCH OF LASHBROOK L. COOK, APPROXIMATELY 640 ACRES IN SIZE, BUT ONLY TO THE EXTENT THAT SUCH PERSONS ADDRESSED IN THIS SUBPARAGRAPH (3) HAVE PREVIOUSLY BEEN OR MAY HEREAFTER BE GIVEN EXPRESS WRITTEN AUTHORIZATION TO SHARE IN THE USE OF A PORTION OF SAID EASEMENTS TO GAIN ACCESS TO THE WATERS OF BEAR LAKE, FOR THE TIME PERIODS AND SUBJECT TO THE CONDITIONS SPECIFIED THEREIN; AND (4) FOR THE LIMITED USE REASONABLY NECESSARY TO ALLOW ANY GOVERNMENT OFFICIAL OR PUBLIC SAFETY EMPLOYEE TO ACCOMPLISH THE OFFICIAL PURPOSES OF THEIR PUBLIC EMPLOYMENT. NO OTHER GRANT OF ANY INTEREST IN SAID PRIVATE EASEMENTS AS ARE SHOWN HEREON IS HEREBY MADE OR INTENDED, IT BEING SPECIFICALLY UNDERSTOOD THAT THE INTENT OF THESE OWNERS AND GRANTORS IS TO AVOID THE CREATION OF OR THE CONFERRAL ON OR IN FAVOR OF ANY MEMBER OF THE GENERAL PUBLIC, ANY POWER, RIGHT, PRIVILEGE, LICENSE, OR OTHER INTEREST OF ANY KIND IN SAID PRIVATE EASEMENTS.
