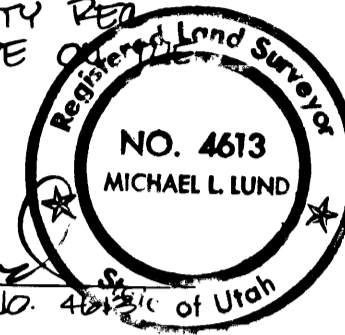

BEGINNING AT A POINT WHICH LIES NORTH 0°00'00" E, 1791.47 FEET OF THE SOUTHWEST CORNER OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE NORTH, PARALLEL TO THE WEST LINE OF SAID SECTION 28, 467.78 FEET; THENCE NORTH 89°59'36" EAST, 772.44 FEET; THENCE SOUTH 0°00'24" EAST, 60.76 FEET; THENCE 123.46 FEET ALONG THE ARC OF A 70.60 FOOT RADIUS CURVE TO THE LEFT WHOSE LONG CHORD BEARS SOUTH 44°59'48" WEST, 111.16 FEET; THENCE SOUTH, 336.29 FEET; THENCE SOUTH 89°49'02" WEST, 693.86 FEET TO THE POINT OF BEGINNING, CONTAINING 7.56 ACRES.

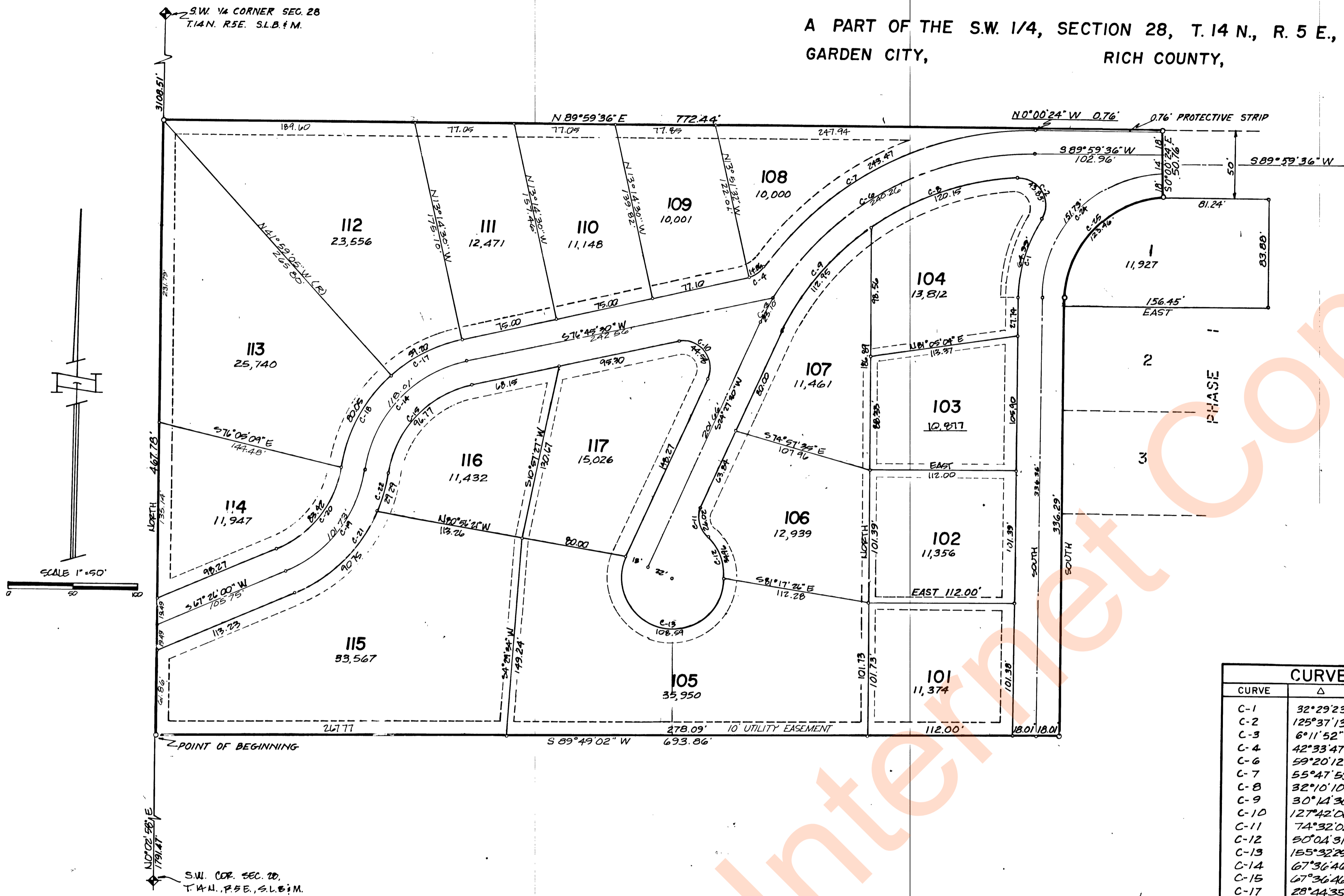
