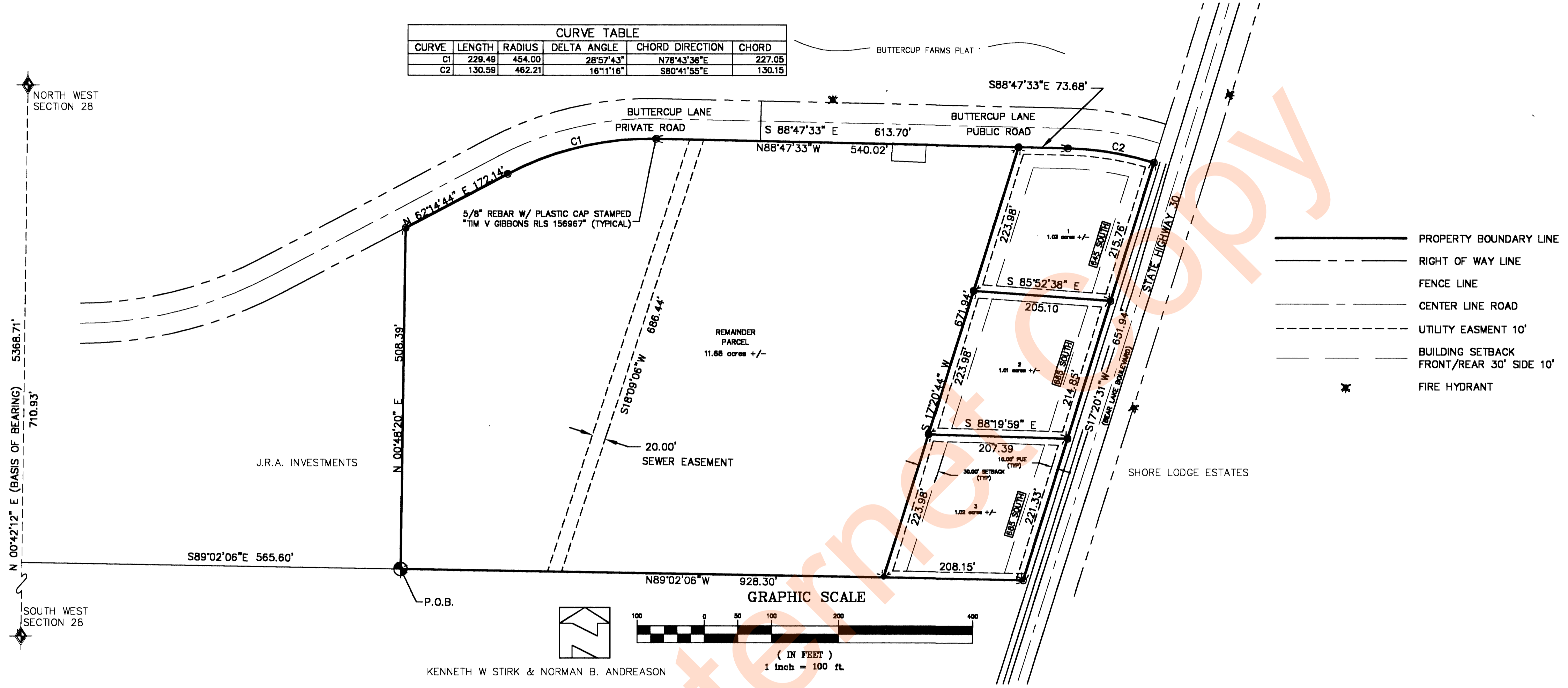


**LAKESIDE SUBDIVISION

A PART OF THE NORTHWEST QUARTER OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN, LOCATED IN RICH COUNTY, UTAH.

COMMENCING AT THE REBAR MONUMENT FOUND AT THE NORTHWEST CORNER OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 5 EAST, OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE S00°42'12"E ALONG THE WEST SECTION LINE OF SECTION 28 710.93 FEET; THENCE S89°02'03"E 565.60 FEET TO THE TRUE POINT OF BEGINNING; THENCE N00°48'20"E 508.39' TO A POINT IN THE SOUTH RIGHT OF WAY LINE OF BUTTERCUP LANE; THENCE N62°14'44"E 172.14 FEET ALONG SAID RIGHT OF WAY LINE; THENCE NORTHEASTERLY ALONG SAID RIGHT OF WAY LINE THAT CURVES TO THE RIGHT ALONG A 454.00 FOOT RADIUS 228.49 (CHORD BEARS N76°43'36"E) FEET; THENCE S88°47'33"E ALONG SAID RIGHT OF WAY LINE 613.70 FEET; THENCE SOUTHEASTERLY ALONG SAID RIGHT OF WAY LINE THAT CURVES TO THE RIGHT ALONG A 482.21 FOOT RADIUS 130.58 FEET (CHORD BEARS S80°41'55"E) TO A POINT IN THE WEST RIGHT OF WAY LINE OF STATE HIGHWAY 30; THENCE S17°20'31"W ALONG SAID RIGHT OF WAY LINE 651.94 FEET; THENCE N89°02'06"W 928.30 FEET TO THE TRUE POINT OF BEGINNING CONTAINING 4 PARCELS AND 14.74 ACRES ±.
