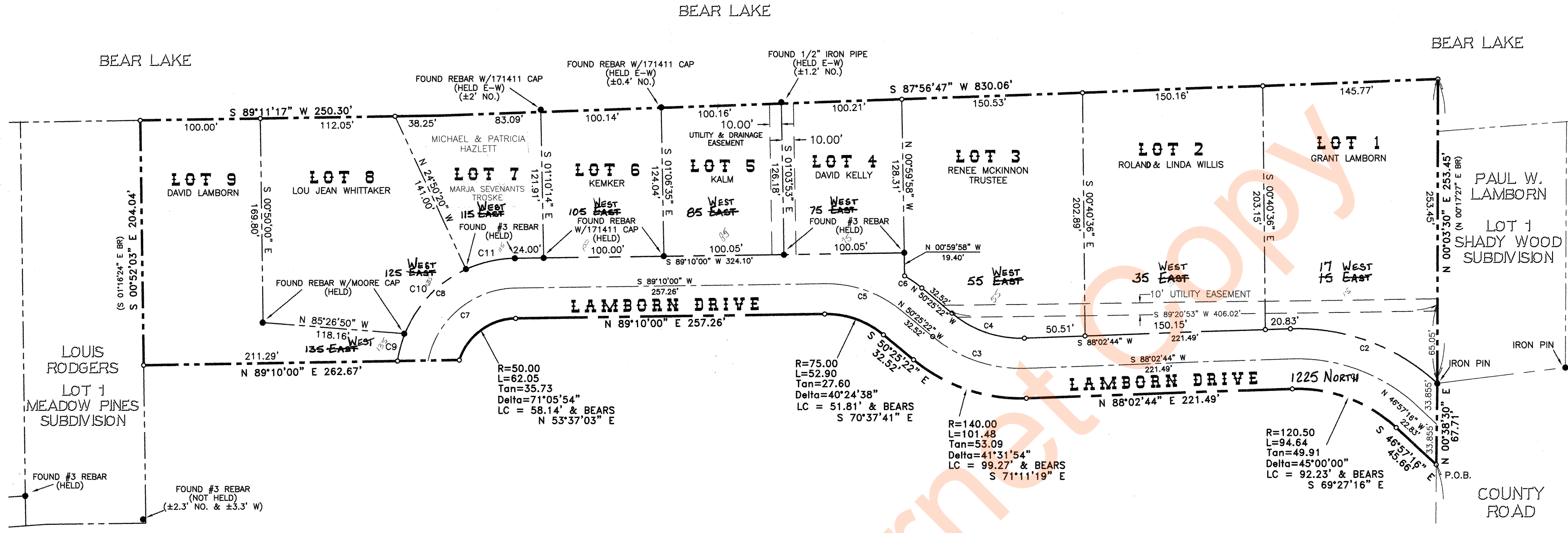
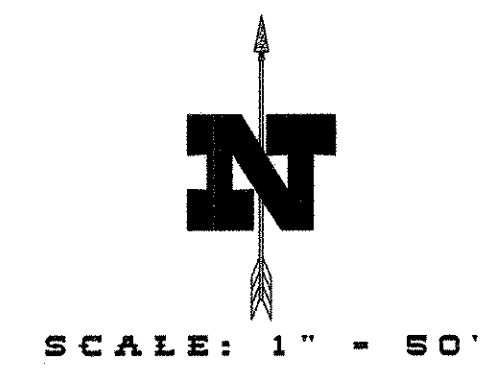

BOUNDARY DESCRIPTION

COMMENCING AT THE MARKED STONE FOUND AT THE EAST QUARTER CORNER OF SECTION 30, TOWNSHIP 13 NORTH, RANGE 6 EAST OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE NORTH 89°50'23" WEST (BASIS OF BEARING) 5312.60 FEET TO A REBAR FOUND NEAR THE EAST QUARTER CORNER OF SECTION 25, TOWNSHIP 13 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN; THENCE NORTH 00°17'52" EAST 2263.17 FEET TO THE TRUE POINT OF BEGINNING; AND RUNNING THENCE NORTH 00°38'30" EAST 67.71 FEET TO AN EXISTING IRON PIN FOUND AT THE SOUTHWEST CORNER OF LOT 1 OF THE SHADY WOOD SUBDIVISION; THENCE NORTH 00°03'30" EAST (NORTH 00°17'27" EAST BY RECORD) ALONG THE WEST LINE OF SAID SUBDIVISION AND THE PROJECTION THEREOF 253.45 FEET MORE OR LESS TO THE HIGH WATER MARK OF BEAR LAKE; THENCE ALONG SAID HIGH WATER LINE THE FOLLOWING TWO COURSES: 1) SOUTH 87°56'47" WEST 830.06 FEET; 2) THENCE SOUTH 89°11'17" WEST 250.30 FEET TO THE NORTHEAST CORNER OF LOT 1 OF THE MEADOW PINES SUBDIVISION; THENCE SOUTH 00°52'03" EAST (SOUTH 01°16'24" EAST BY RECORD) ALONG SAID EAST SUBDIVISION LINE 204.04 FEET; THENCE NORTH 89°10'00" EAST 262.67 FEET TO THE POINT OF A NONTANGENT CURVE; THENCE 62.05 FEET ALONG THE ARC OF A 50.00 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 71°05'54" AND A LONG CHORD THAT BEARS NORTH 53°37'03" EAST 58.14 FEET; THENCE NORTH 89°10'00" EAST 257.26 FEET; THENCE 52.90 FEET ALONG THE ARC OF A 50.00 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 40°24'38" AND A LONG CHORD THAT BEARS SOUTH 70°37'41" EAST 51.81 FEET; THENCE SOUTH 50°25'22" EAST 32.52 FEET; THENCE 101.48 FEET ALONG THE ARC OF A 140.00 FOOT RADIUS CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 41°31'54" AND A LONG CHORD THAT BEARS SOUTH 71°11'19" EAST 99.27 FEET; THENCE NORTH 88°02'44" EAST 221.49 FEET; THENCE 94.64 FEET ALONG THE ARC OF A 120.50 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 45°00'00" AND A LONG CHORD THAT BEARS SOUTH 69°27'16" EAST 92.23 FEET; THENCE SOUTH 48°57'16" EAST 45.66 FEET TO THE POINT OF BEGINNING. CONTAINING 5.36 ACRES AND 9 LOTS.
