COMMENCING AT THE B.L.M. BRASS CAP MONUMENT FOUND AT THE SOUTHWEST CORNER OF SECTION 36, TOWNSHIP 13 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE NORTH 00°00'00" EAST ALONG THE WEST LINE OF SAID SECTION AS CURRENTLY MONUMENTED 1835.92 FEET TO THE TRUE POINT OF BEGINNING; AND RUNNING THENCE NORTH 00°00'00" WEST ALONG SAID WEST SECTION LINE 457.32 FEET TO A POINT ON THE SOUTHERLY RIGHT OF WAY LINE OF CENTER STREET (OLD STATE HIGHWAY PROJECT #S-0551(1)); THENCE LEAVING SAID SECTION LINE NORTHEASTERLY ALONG SAID SOUTHERLY RIGHT OF WAY LINE THE FOLLOWING 2 COURSES: 1) NORTH 76°40'23" EAST 55.83 FEET; 2) THENCE NORTH 73°22'41" EAST 1301.32 FEET TO ENGINEERS STATION 63+73.4 70.00 FEET LEFT, SAID POINT BEING THE NORTHWEST CORNER OF PHASE I OF THE LAST CHANCE SUBDIVISION; THENCE LEAVING SAID SOUTHERLY RIGHT OF WAY LINE SOUTH 12°39'25" WEST ALONG SAID WEST BOUNDARY LINE 604.37 FEET TO THE SOUTHWEST CORNER OF LOT 10 OF SAID PHASE I; THENCE LEAVING SAID WEST BOUNDARY LINE SOUTH 77°47'54" WEST 1195.86 FEET TO THE POINT OF BEGINNING.
