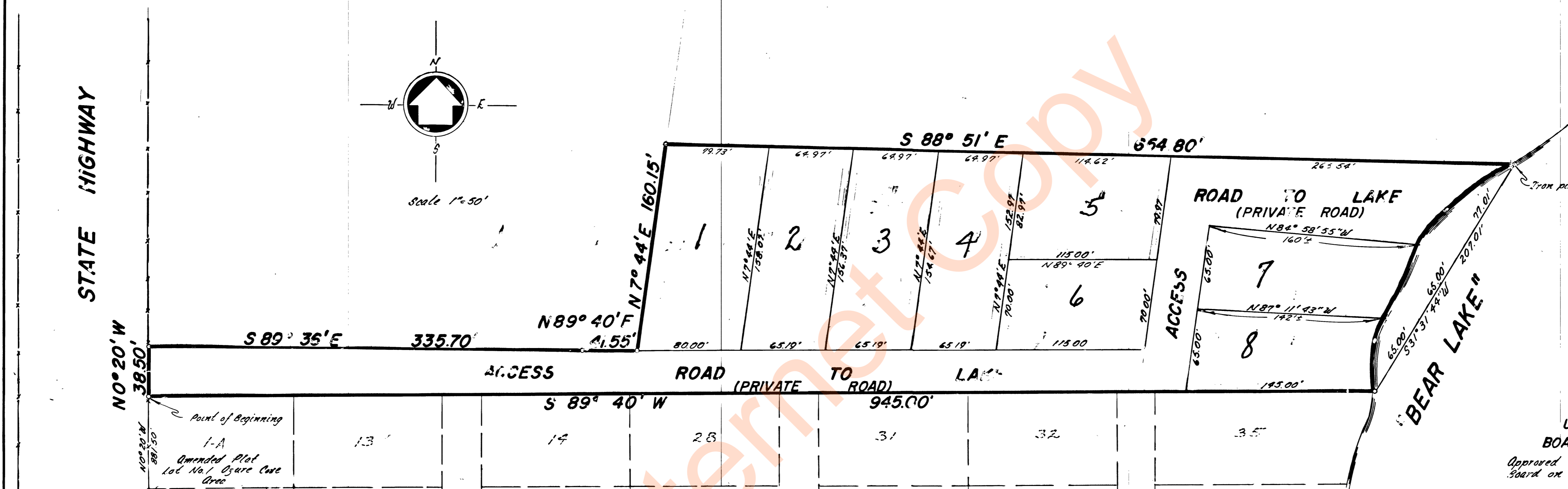


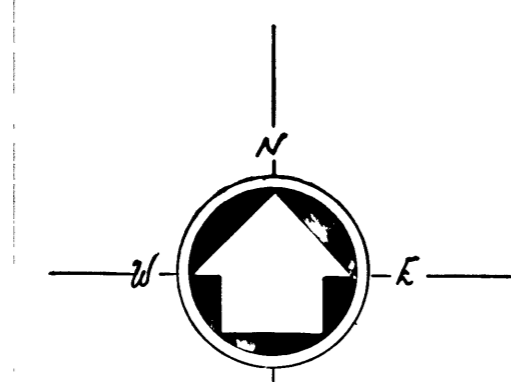
LIDO POINT SUBDIVISION

BOUNDARY DESCRIPTION
A part of Section 21, T14N, R5E, SLB & M. U.S. Survey:
Beginning at the N.W. corner of lot 1-A Amended Plat of Lot No. 1, Azure Cove Area, Garden City, Rich County, Utah, said point being East 1792.51 ft., N16°22'12"E 462.0 ft., and N0°20'W 881.50 ft. from the SW corner of said Section 21, running thence N0°20'W 385.0 ft. along the East line of the State Highway, thence S89°36'E 335.70 ft., thence N89°40'E 41.55 ft., to an existing fence, thence N7°44'E 160.15 ft. along said fence to a fence corner, thence S88°51'E 654.80 ft. along an existing fence to an iron pin on the westerly shore line of Bear Lake, thence Southerly along said shore line 215 ft. to the N.E. corner of lot 35 Azure Cove Area (said point being S31°31'44"W 207.01 along a line from the iron pin) thence S89°40'W 945.00 ft. along the northerly boundary of Azure Cove area to the point of beginning.

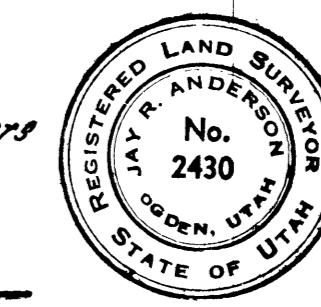
SURVEYOR'S CERTIFICATE
