If the amount due is not paid on or before January 31, 2023 at 5:00 pm at the Rich County Treasurer office located at 20 South Main Street, Randolph, Utah the penalty currently due will increase to the greater of \$10.00 or 2 1/2% of the amount of tax due as of December 1, 2022. Plus interest will be charged at the interest rate set in accordance with Utah Code Annotated, Title 59, Chapter 2, Part 13, Section 1331 on the balance due as of January 31, 2023 from January 2, 2023 until the balance is paid in full.
